Referring to KSEI Announcement No. KSEI-8270/DIR/1221, dated December 3, 2021, regarding Rescheduling of C-BEST and S-Invest Operational Activities and Bank Indonesia Press Release Number 23/1190/DPSP/Adm on December 1, 2021, regarding Adjustment to the BI-RTGS, BI-SSSS, and BI ETP Systems' Operational Hours for the End of the Year 2021, we hereby remind you on the adjustments to the C-BEST and S-Invest operational hours. The adjustments refer to Bank Indonesia stipulations that the extended operational hours for BI-RTGS and BI-S4 markets only applies for the month of December 2021.
