Referring to KSEI Announcement No. KSEI-17973/JKU/0921, September 20, 2021, and information we received from PT Indosat Tbk on December 27, 2021, we hereby inform you that PT Indosat Tbk (ISAT) and PT Hutchinson 3 Indonesia's Merger Plan Schedule has been revised.
