With the upcoming Holy Month of Ramadan 1445 H/2024 AD, we hereby inform you that KSEI will adjust the operational activity times for C-BEST and S-INVESTas scheduled below.

The time adjustment will only be implemented during the month of Ramadan 1445 Hijri, with the 1st date of Ramadan to follow the official announcement from the Government. C-BEST and S-INVEST's operational times will return to normal on the first trading day after the Eid Fitr 1445 Holiday, which the Indonesia Stock Exchange will determine. This return to regular operational hours is specified in KSEI Announcement Number KSEI-2509/DIR/0823, dated August 9, 2023, regarding the Readjustment of C-BEST and S-INVEST's Operational Activity Schedule.


