Referring to KSEI Announcements No. KSEI-5338/JKU/0324, dated March 18, 2024, and information we received from PT Nusantara Infrastructure Tbk, we hereby inform you that there will be an extension for the Stock Voluntary Tender Period for public shareholders with an offering price of Rp250 (two hundred fifty rupiahs) per Share and details as follows:

1. Period Extension
