## Re: Additional Information on PT XL Axiata Tbk and PT Smartfren Telecom Tbk Merger

Dear Sir/Madam,

As a follow-up to KSEI Announcement No. KSEI-8213/JKU/0425, dated April 16, 2025, regarding Additional Information on PT XL Axiata Tbk and PT Smartfren Telecom Tbk (the "Company") Merger Ratio based on PT Smartfren Telecom Tbk Series III Warrants Exercise, and information from PT XL Axiata Tbk dated April 16, 2025, it is hereby conveyed that:

- On April 15, 2025, PT XL Axiata Tbk (XL), PT Smartfren Telecom Tbk (SF), and PT Smart Telecom (ST) signed the Deed of Merger No. 33, dated April 15, 2025, whereby SF and ST agreed to merge with XL as the Surviving Company. Accordingly, the legal status of SF and ST is terminated by operation of law (Merger). In connection with the Extraordinary General Meeting of Shareholders held by XL on March 25, 2025, related to the Merger, XL also signed the Extraordinary General Meeting of Shareholders Minutes No. 34, dated April 15, 2025.
- The Merger, the Amendment of XL's Articles of Association, and the Amendment of XL's Data as a result of the Merger have received approval and/or acknowledgment notifications from the Minister of Law and Human Rights of the Republic of Indonesia (Menkum) as follows: (i) Receipt of the Notification of the Merger of the Company by Menkum No. AHU-AH.01.09-0189492 dated April 16, 2025; (ii) Ministry of Law Decree on Approval of XL Articles of Association Amendments No. AHU-0026805.AH.01.10. Year 2025, dated April 16, 2025 (Approval Decree);

(iii) Receipt of the Notification of Amendments to XL Articles of Association by the Ministry of Law No. AHU-AH.01.03-0102806, dated April 16, 2025; and (iv) Receipt of the Notification of Amendments to XL Data by the Ministry of Law No. AHU-AH.01.03-0102812, dated April 16, 2025.
