1. XL AXIATA SHELF-REGISTRATION BOND I PHASE I YEAR 2018 SERIES D (EXCL01DCN1)

Approve the distribution of an incentive of 0.3958% (zero point three nine five eight percent) of the outstanding principal amount of XL Axiata Shelf Registration Bond I Phase I Year 2018 Series D, to be distributed proportionally to the Bondholders of XL Axiata Shelf Registration Bond I Phase I Year 2018 Series D.

2. XL AXIATA I PHASE I YEAR 2018 SERIES E SHELF-REGISTRATION BOND (EXCL01ECN1)

4. XL Axiata Shelf Registration Ijara Sukuk II Phase I Year 2018 Series E (SIEXCL02ECN1)

Approve the distribution of an incentive of 0.5% (zero point five percent) of the unpaid remaining Ijara Fee of XL Axiata Shelf Registration Ijara Sukuk II Phase I Year 2018 Series E, to be distributed
