Referring to KSEI Announcement Number No KSEI-7042/JKS/0607 dated June 25, 2007 regarding Schedule of Stock Dividend of PT Globalindo Mediacom Tbk (BMTR) for the Book Year 2004 and the information we received from PT Globalindo Mediacom Tbk (BMTR) through Letter No. 077-BEJ/MCOM-FIN/VII/07 dated July 16, 2007 regarding Additional Information of Cash Dividend for the Book Year 2004, please be informed of the Stock Dividend Calculation of PT Globalindo Mediacom Tbk (BMTR) for the Book Year 2004, either for the cash dividend or dividend in form of Mobil-8 stocks, using the formula as follows,

1. the total number of Company's shares as of July 16, 2007 (DPS date) is 13.022.431.550 stocks (excluded those which are distributed without Right Proceeds Share, referred to the General Shareholder Meeting dated March 27, 2007, are 685.168.000 stocks). Thus, the calculation of cash dividend value per share is as follows:

 $\frac{\text{Rp. }161.846.666.592}{13.707.599.550} = \text{Rp. }12.43 \text{ per share}$ 

2. Shareholders who prefer to have dividend in form of Mobile-8 stocks will refer to the following calculation: the stock average price of FREN for 25 Exchange Days prior to the date of Shareholders List entitled for dividend (July 16, 2007) is Rp. 301.8 per share

Calculation sample for acquiring Mobile-8 stocks

Total stock x Rp 12.43 = Gross

Gross - tax = Net

<u>Net</u> = rounded number of FREN stocks acquired Rp. 301,8
