2. The dividend per Share amounts to US\$ 0.07, to be distributed to shareholders of PT Citra Tubindo Tbk **in the amount of Rp 644,70 (Six hundred and forty four point seventy Rupiah).**

Dividend will be paid in US Dollars (USD) to those Shareholders that have submitted written confirmation requesting for such a dividend payment in USD. Those Shareholders that have not will receive dividend payment in Indonesian currency.
