**REGARDING**  
**THE REGULATION OF PT KUSTODIAN SENTRAL EFEK INDONESIA**  
**NUMBER VIII REGARDING SANCTIONS OF KSEI**

- Considering :
- a. Whereas PT Kustodian Sentral Efek Indonesia (“KSEI”) acting as a Central Securities Depository, in relation to provide central Custody and Securities transaction settlement services, authorize to organize those activities for all Service User in order to run organized, fair and efficient services as mandated in the Law Number 8 of the year 1995 regarding Capital Market.
  - b. Whereas to ensure the usage of the KSEI services are organized, fair and efficient, it is considered to regulate the imposition of sanction to the Service User whose committed violation against the regulation of KSEI.
  - c. Whereas based on the above mentioned consideration, it is considered necessary to draft the regulation of KSEI regarding Sanctions of KSEI.

Regulation of the Capital Market Supervisory Agency Number X.C.1 Regarding Central Securities Depositor Reports (Attachment to the Decree of the Chairman of the Capital Market and Financial Institutions Supervisory Agency Number KEP-182/BL/2009 dated June 30, 2009, regarding Central Securities Depository Reports).
  - e. Decree of the Chairman of the Capital Market Supervisory Agency Number KEP-54/PM/1998 dated November 11, 1998, regarding the Granting of Business Permit as Central Securities Depository to PT Kustodian Sentral Efek Indonesia.

- f. Letter of the Board of Commissioners of the Financial Services Authority Number S-176/PM.2/2014 dated November 26, 2014, regarding the Approval over the Regulation of KSEI regarding the Inspections, Sanctions and Securities Ownership Reference (AKSes).

**HAS DECIDED**

- To stipulate : 1. Regulation of PT Kustodian Sentral Efek Indonesia (KSEI) Number VIII Regarding Sanctions of KSEI as contained in the attachment to this decree.
2. Any matters which need to be further stipulated from this Regulation will be stipulated in circular letters to be issued in the future by KSEI.
3. This Board of Directors Decree will be effective starting as of its date of stipulation, provided that any and all things will be amended and corrected accordingly, should there is any mistake in its stipulation and/or if considered necessary to make any correction over this Decree of the Board of Directors.
