THE REGULATION OF PT KUSTODIAN SENTRAL EFEK INDONESIA NUMBER VII REGARDING INSPECTIONS OF KSEI

Considering: a. Whereas PT Kustodian Sentral Efek
Indonesia ("KSEI") acting as a Central
Securities Depository, in relation to
provide central Custody and Securities
transaction settlement services, authorize
to organize those activities for all
Service User in order to run organized,
fair and efficient services as mandated in
the Law Number 8 of the year 1995
regarding Capital Market.

b. Whereas to ensure Service User compliance to use KSEI services as mandated in the KSEI Regulation, it is required inspection process to Service User performed by KSEI.



c. Whereas based on the above mentioned consideration, it is considered necessary to draft the regulation of KSEI regarding Inspections of KSEI.
