**THE REGULATION OF PT KUSTODIAN SENTRAL EFEK INDONESIA (KSEI) NUMBER IV-D
REGARDING CORPORATE ACTION FOR ASSETS BACKED SECURITIES IN KSEI**

- Considering :
- a. Whereas to follow up the Regulation of the Financial Services Authority number 23/POJK.04/2014 regarding Guidance for Issuing and Reporting Asset Backed Securities in the Form of Participatory Notes for Secondary Financing for Housing, its implementation regulation is necessary to be made by KSEI as Central Securities Depository related to Corporate Action for Assets Backed Securities in the form of Participation Notes at KSEI.
 - b. Whereas the Regulation of KSEI regarding Central Custodian Services (Attachment to Decree of the Board of Directors of KSEI Number KEP-0013/DIR/KSEI/0612 regarding The Amendment to Central Custodian Services Regulation) needs to be adjusted by accommodating the needs of Corporate Action for Assets Backed Securities in the form of Participation Notes at KSEI as referred to in the Regulation of the Financial Services Authority number 23/POJK.04/2014 regarding Guidance for Issuing and Reporting Asset Backed Securities in the Form of Participatory Notes for Secondary Financing for Housing.
 - c. Whereas based on the above mentioned considerations, it is considered necessary to determine the KSEI Regulation regarding Corporate Action for Assets Backed Securities.

 - d. Regulation of the Financial Services Authority Number 23/POJK.04/2014 regarding Guidance Issuing and Reporting Asset Backed Securities in the Form of Participatory Notes for Secondary Financing for Housing (State Gazette of the Republic of Indonesia Number 358 of the year 2014).
 - e. Letter of the Board of Commissioners of the Financial Services Authority Number S-66/PM.2/2015 dated August 21, 2015 regarding Approval on the KSEI Regulation regarding Registration of Assets Backed Securities, Depository of Assets Backed Securities, and Corporate Action for Assets Backed Securities.

HAS DECIDED

- To Stipulate
1. Regulation of PT Kustodian Sentral Efek Indonesia (KSEI) Number IV-D regarding Corporate Action for Assets Backed Securities in KSEI as contained in the attachment to this decree.

2. With the enactment of Regulation of KSEI regarding Corporate Action for Assets Backed Securities as referred to in point 1 above, the provisions regarding Corporate Action for Assets Backed Securities as stipulated in the Regulation of KSEI regarding Central Custodian Services (Attachment to The Decree of The Board of Directors of KSEI Number KEP-0013/DIR/KSEI/0612 regarding the Amendment to Regulation of Central Custodian Services) is revoked and declared no longer valid.
3. This Board of Directors Decree will be effective as of its date of stipulation provided that any and all things will be amended and corrected accordingly if there is any mistake in its stipulation and/or it is considered necessary to make correction over this Decree.
