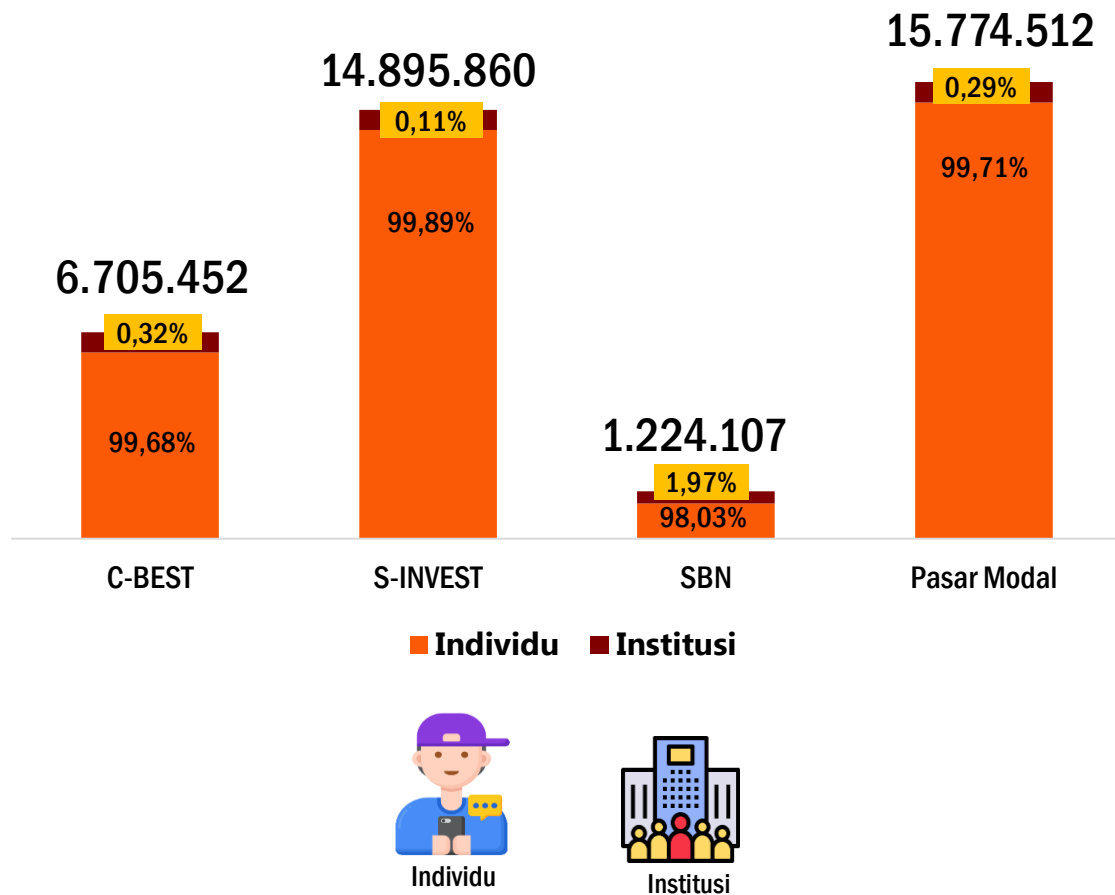

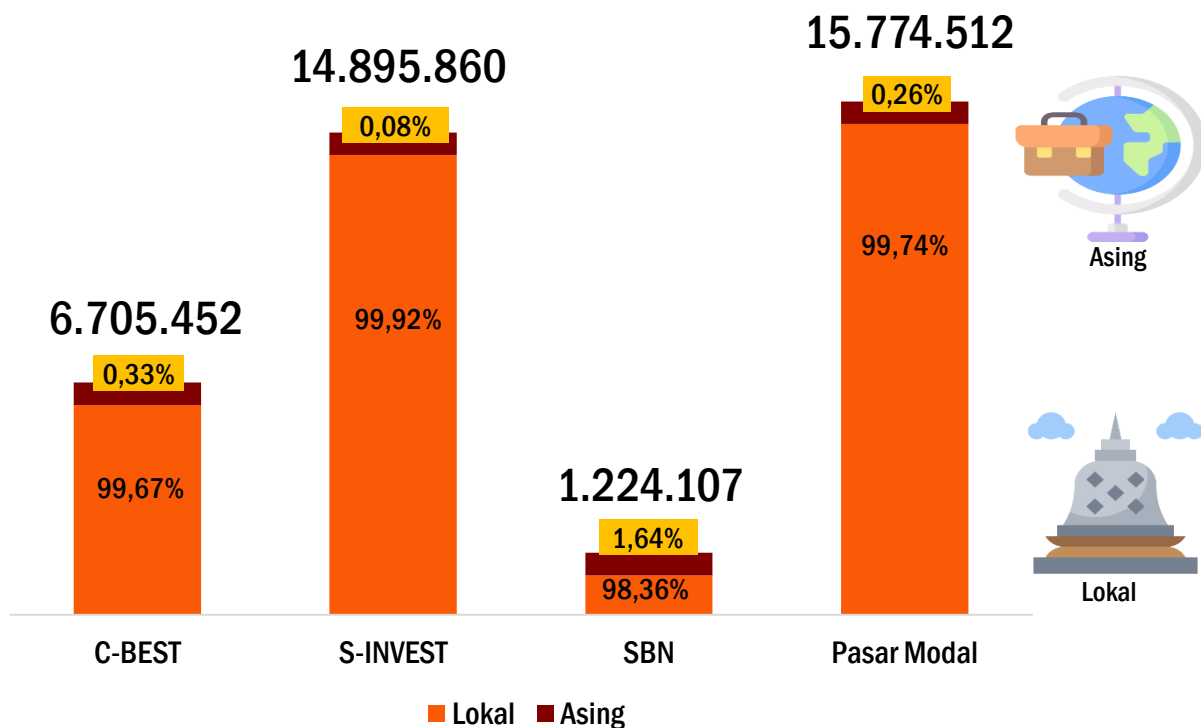
## Komposisi Individu-Institusi



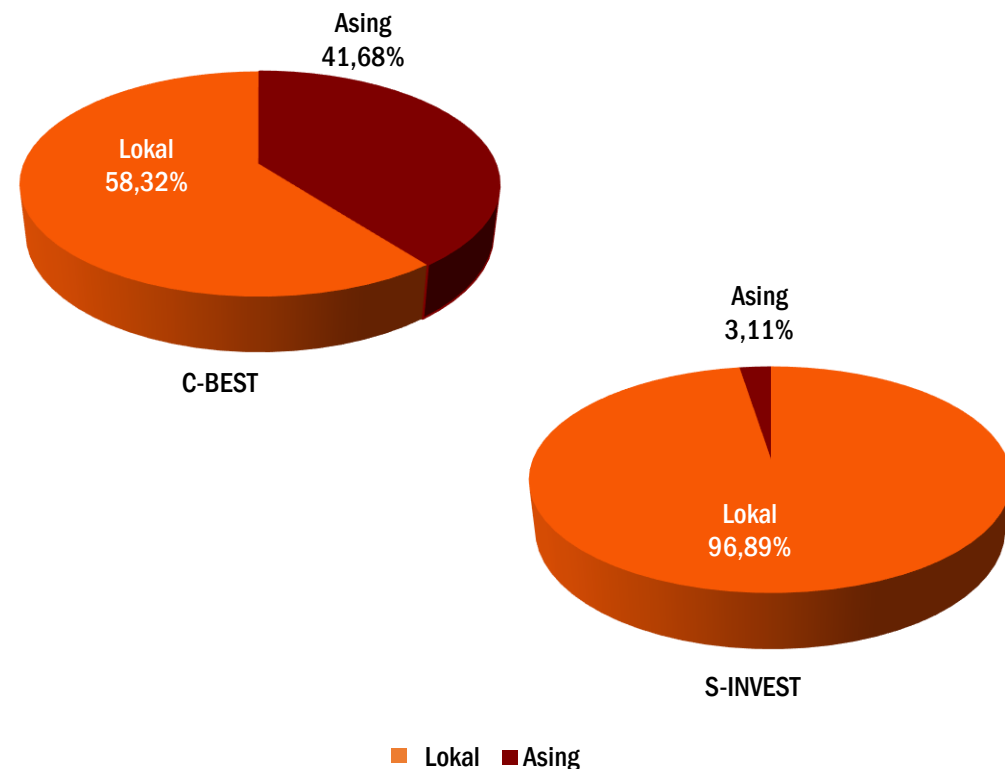

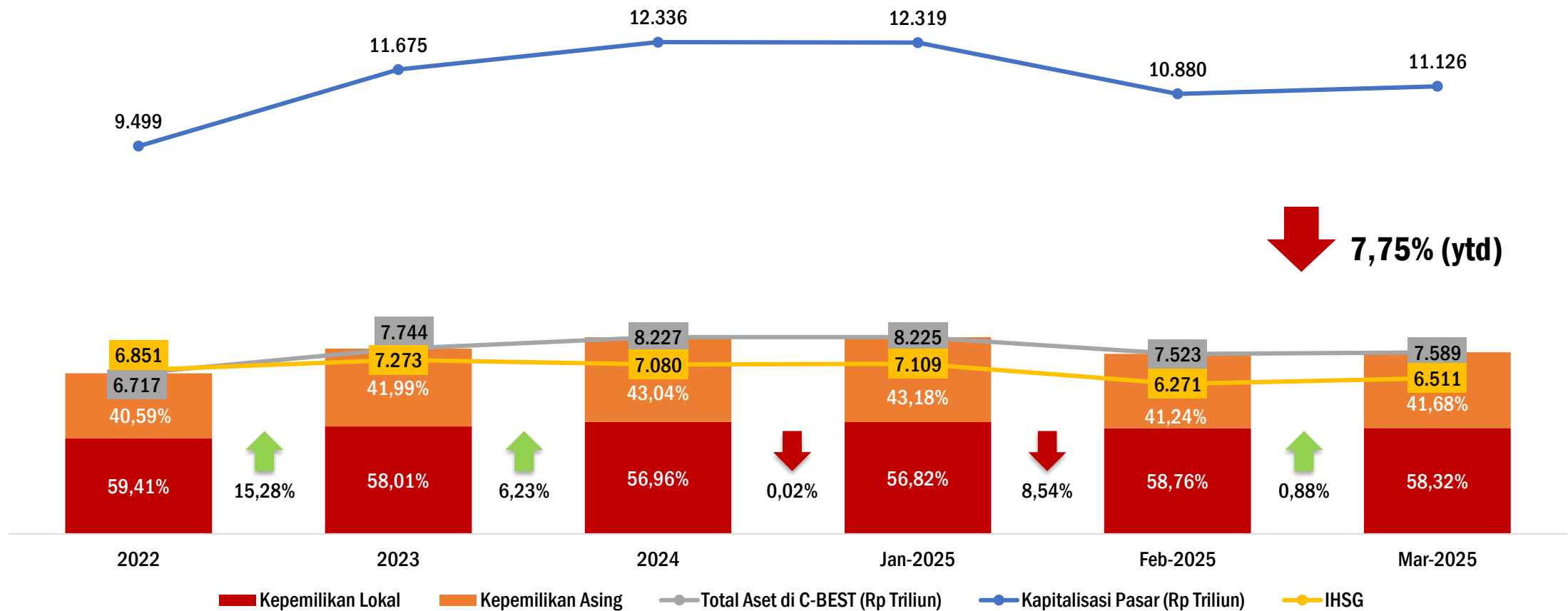

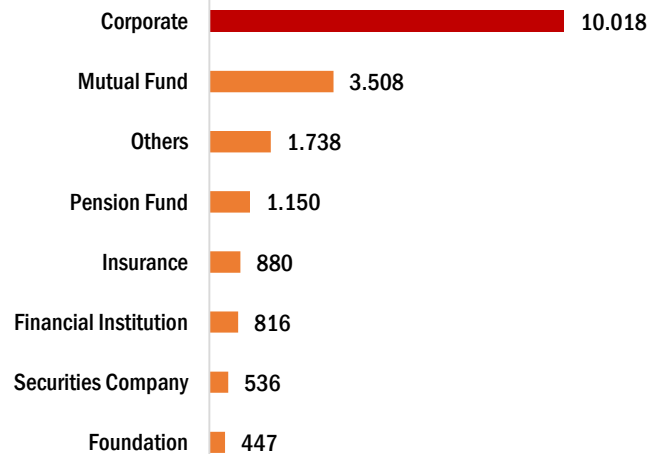

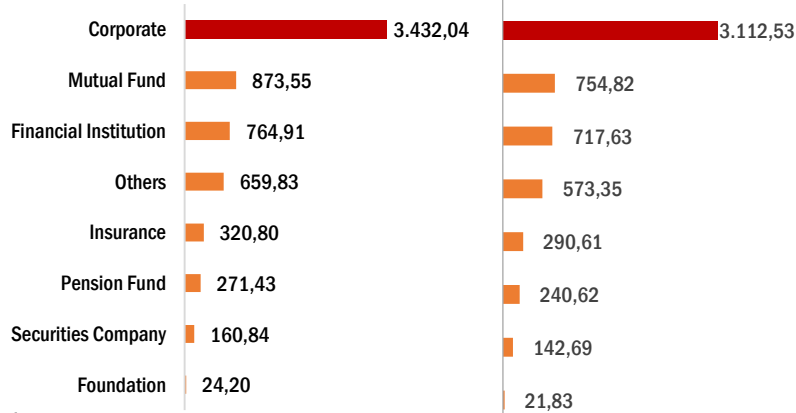

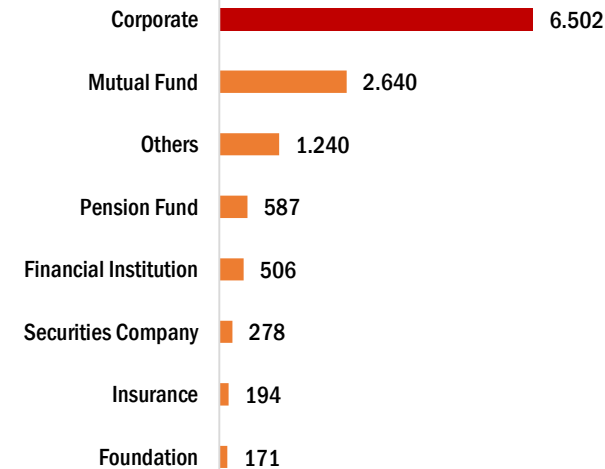

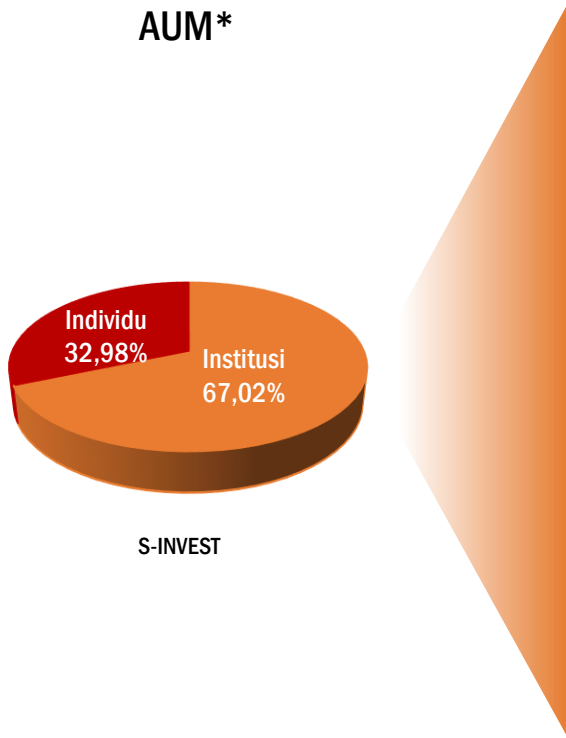

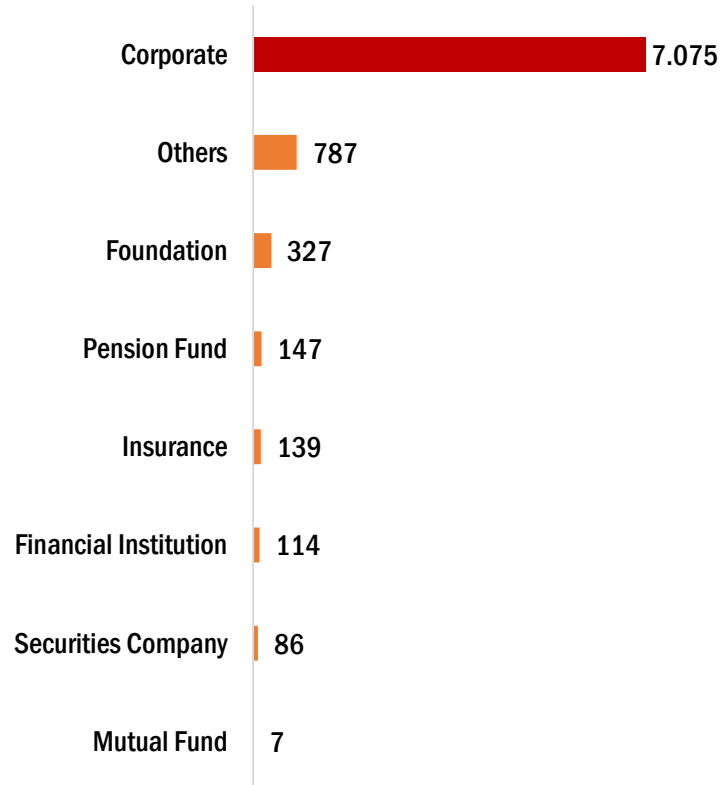

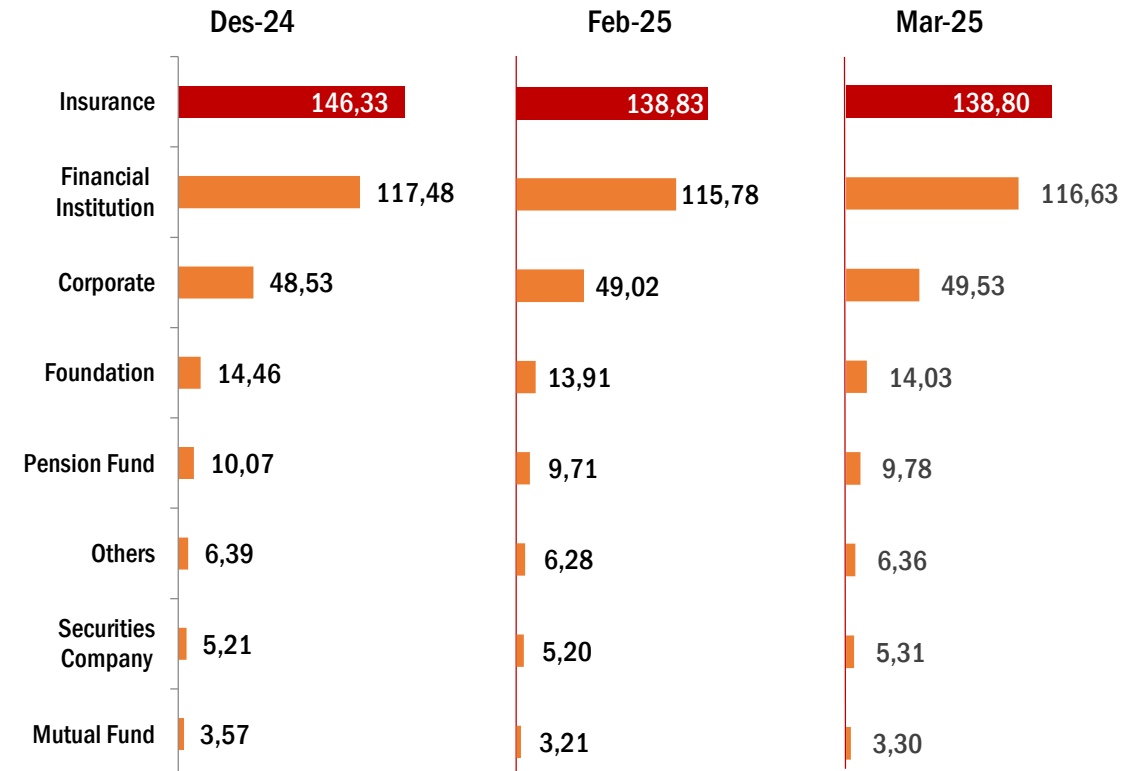
### Persentase Nilai AUM\*
