**THE REGULATION OF PT KUSTODIAN SENTRAL EFEK INDONESIA NUMBER XII-A  
REGARDING  
KNOW YOUR CUSTOMER PRINCIPLES ADMINISTRATION SERVICES AT KSEI**

- Considering : a. Whereas PT Kustodian Sentral Efek Indonesia (KSEI) as the Central Securities Depository has been appointed as the Organizer of Know Your Customer Principles Administration Services (LAPMN) based on the Regulation of the Financial Services Authority Number 15 of the Year 2023 regarding the Implementation of Know Your Customer Principles Administration Services.
- b. Whereas to fulfill the provisions of the laws and regulations, KSEI as the Organizer of LAPMN shall have provisions regarding the implementation of LAPMN in order to ensure the utilization of LAPMN can run efficiently, fairly, and regularly.
- c. Whereas KSEI as the Central Securities Depository has carried out development in order that LAPMN can be implemented, thus creating efficiency for the implementation of Customer Due Diligence (CDD) and/or Enhanced Due Diligence (EDD) with the centralization of data and/or documents of the Prospective Customers and/or the Customers of the Users of LAPMN.
- d. Whereas based on the considerations as referred to in point a up to point c above, KSEI considers it necessary to issue provisions regarding the implementation of Know Your Customer Principles Administration Services at KSEI through the Regulation of KSEI Number XII-A regarding the Know Your Customer Principles Administration Services at KSEI.
- In View of : a. - i. Decree of the Board of Commissioners of the Financial Services Authority Number KEP-4/D.04/2024 dated January 30, 2024, regarding the Appointment of PT Kustodian Sentral Efek Indonesia as the Organizer of Know Your Customer Principles Administration Services.
- j. Letter of the Financial Services Authority Number S-27/PM.01/2024 dated February 6, 2024, regarding the Approval over the Draft Regulation of KSEI Number XII-A regarding the Know Your Customer Principles Administration Services at KSEI.

#### **HAS DECIDED**

- To stipulate : 1. Regulation of KSEI Number XII-A regarding Know Your Customer Principles Administration Services at KSEI.
2. Provisions regarding the implementing regulations, implementing mechanisms, as well as matters which have not yet been sufficiently stipulated in the Regulation of KSEI Number XII-A regarding the Know Your Customer Principles Administration Services at KSEI shall be further stipulated in the Circular Letter of KSEI.
3. Data and/or the documents of the Customers who have Single Investor identification (SID) and have been registered at KSEI up to February 11, 2024, can be used for the purpose of storage of data and/or documents of the Customers at LAPMN in the framework of implementation of LAPMN by KSEI as the Organizer of LAPMN.
4. The Users of LAPMN may use data and/or documents of the customers received from LAPMN as referred to in Point 3 above to facilitate the interest of the Prospective Customers and/or the Customers of the Users of LAPMN, to the extent they have obtained written approval from the Prospective Customers and/or the Customers.

5. This Decree of the Board of Directors shall be effective starting as of the date of stipulation provided that any and all things shall be amended and corrected accordingly, if there were any mistakes in the stipulation and/or considered necessary to be made any correction over this Decree of the Board of Directors.
