Indonesian Capital Market to Donate Thousands of Blood Bags

September 17, 2021

Jakarta - Self-Regulatory Organizations (SRO), comprising of the Indonesia Stock Exchange (BEI), the Indonesian Clearing and Guarantee Corporation (KPEI), and the Indonesia Central Securities Depository (KSEI) have launched a series of Corporate Social Responsibility (CSR) activities to commemorate the 44th anniversary of the Indonesian Capital Market's reactivation. The SROs held their CSR fund drive on September 17, 2021, which coincided with the Indonesian Red Cross (PMI) Day.

The event is a follow-up to their previous CSR fund drive on August 9, 2021. As of September 15, 2021, the CSR fund drives have gathered Rp36.2 billion in donations, in which Rp11.3 billion came from capital market and custodian service revenues on August 9, 2021; meanwhile, Rp24.9 billion came from Indonesian Capital Market industry participant's donations. The collected CSR funds were used to aid COVID-19 pandemic responses.

Meanwhile, all SRO revenues from Indonesian Capital Market investor transactions and custodian services on September 17, 2021, would also be converted into the CSR fund. Based on the assumptions that the day's transactions would be around Rp9 trillion to Rp15 trillion, the allocated CSR fund from September 17, 2021 capital market transactions and custodian services can reach up to Rp5 billion to Rp8 billion.

This week, on Friday, September 17, 2021, SROs and the PMI would also simultaneously launch a blood and convalescent plasma drive in several cities. The cities are Jakarta's five municipalities, Banjarmasin, Batam, Bengkulu, Kediri, Kendari, Makassar, Malang, Mataram, Semarang, Surabaya, and Pangkal Pinang. The event was held to support PMI's blood and convalescent plasma supply requirements, which have been limited due to increased use during the COVID-19 pandemic. The blood drive aims to gather ten thousand blood donors across all of its locations. Several of the blood drive activities have already started since September 13, 2021, in certain cities.

KSEI Director and Head of the Indonesian Capital Market's 44th Anniversary Celebrations' Organizing Committee Syafruddin stated that, "the series of CSR activities to commemorate the Indonesian Capital Market's 44th Anniversary is part of BEI, KPEI, and KSEI's commitment to contribute in mitigating COVID-19 based on this year's theme of 'Capital Market Synergy for Economic Recovery.' We hope that the COVID-19 pandemic can be resolved soon, which would greatly improve public health and the economy's condition." Syafruddin called on the public to make transactions at the capital market on September 17, 2021, and participate in the blood and convalescent plasma drives.

Syafruddin added that 3,050 donors had so far registered for the Surabaya blood drive alone. Besides collecting blood donations, the event - which was attended by the Mayor of Surabaya Eri Cahyadi and Head of the Financial Services Authority's (OJK) Region 4 East Java Branch Office Bambang Mukti Riyadi - also received Rp1.25 billion worth in medical equipment donations for PMI Surabaya, in the











form of five blood collection mixers and 350 aphereses amicore single needle units. Around Rp444 million in monetary assistance were also given to 37 health workers during the occasion. Previously, on September 16, 2021, KPEI's Director and Deputy Head of the Indonesian Capital Market's 44th Anniversary Celebrations' Organizing Committee Iding Pardi also symbolically donated four thousand blood transfusion units for four thousand blood donors at the PMI's headquarters in Jakarta.

The SROs also launched other CSR programs, such as organizing a vaccination center in Jakarta that vaccinated around four thousand people between June 26 and 21 and another center in Mataram, which had vaccinated around 2,400 people since early September 2021. More vaccination centers are planned to be established in other cities outside of Jakarta during the next phase. For this program, the SROs have collaborated with the OJK and local health agencies on organizing the vaccination centers. The next vaccination centers would be opened in Surabaya and Gresik in East Java provinces starting from September 27, 2021, and with a target of 51,000 participants.

SROs have also helped the Indonesian Ministry of Health's program to supply more oxygen tanks for the public. The Ministry's data showcased that around thirty percent of COVID-19 patients vitally require oxygen in their treatments. So far, SROs have distributed Rp1 billion worth of oxygen concentrators to the Ministry of Health's Health Determinant Analysis Center (PADK). SROs also provided the PADK's COVID-19 Emergency Hospitals with 10,000 oximeter units worth Rp556 million. SROs also donated medical supplies to Regional General Hospitals and Public Health Centers in several provinces.

Furthermore, SROs provided special attention to workers impacted by the COVID-19 pandemic, especially health workers and public cemetery staff. SROs have provided Rp12 million monetary assistance for each of the families of health workers who passed away due to COVID-19. Based on the Indonesian Nurses Association (PPNI) data, more than 600 health workers have died while performing their duties during the COVID-19 pandemic. As of August 2021, SROs had provided monetary assistance to 32 families of deceased health workers affiliated with PPNI's main office, with a total donation of Rp384 million. Donations for twenty-three more families of passed away health workers are currently being processed with the Jakarta PPNI for the next phase of the program.

Meanwhile, SROs have provided food and vitamin donations for public cemetery staff since August 2021. Around Rp100 million worth of aid has been granted to 100 staff of the Rorotan Public Cemetery in North Jakarta, 50 staff in Pendurenan Public Cemetery in South Jakarta, and other staff of public cemeteries in Kupang and Batam.
