

## **General Meeting of Shareholders Appoints KSEI Board of Commissioners for the 2026-2030 Period**

Jakarta, June 18, 2026 - The Indonesia Central Securities Depository (KSEI) held its Annual General Meeting of Shareholders (GMS), with one of the agenda items being the appointment of its Board of Commissioners following the end of the incumbent Board's 2022–2026 Term.

The meeting was convened at 9:55 Western Indonesian Time (WIB) and was attended by KSEI Shareholders representing 5,820 Voting Shares, or 97.98%, of the total 6,000 Voting Shares. KSEI Shareholders unanimously approved the appointment of the Board of Commissioners for the 2026–2030 Term, namely A. Fuad Rahmany as President Commissioner, and Indra Christanto and Margeret M. Tang as Commissioners. With this appointment, Fuad Rahmany and Indra Christanto resume their positions on the KSEI Board of Commissioners, while Margeret M. Tang joins as a new member of the KSEI Board of Commissioners for the current Term.

As KSEI's President Commissioner, A. Fuad Rahmany previously served as Chairman of the Capital Market and Financial Institution Supervisory Agency (Bapepam-LK) - Ministry of Finance (2006–2011), Commissioner of the Deposit Insurance Corporation (2009–2014), and Director General of the Directorate General of Taxes - Ministry of Finance (2011–2014), and has served as Commissioner at several other companies since 2014.

Indra Christanto, who is also appointed to the KSEI Board of Commissioners for the second time, currently serves as President Director of PT Panin Sekuritas Tbk, having previously served as its Director from 2012 to 2018. His other experience includes serving as Equity Director of PT Andalan Artha Advisindo (2003–2011), member of the KSEI Budget Committee (2020–2021), member of the APEI Securities Broker-Dealer Department (2020–2023), member of the Trading Committee of PT Bursa Efek Indonesia (2020–2022), and member of the Disciplinary Commission of PT Bursa Efek Indonesia (2022–2024).

As the newest member of the KSEI Board of Commissioners for the 2026–2030 Term, Margeret M. Tang previously led KSEI as Acting President Director (Pjs. Direktur Utama) from 2014 to 2015, having earlier served as Director from 2010 to 2014. Margeret afterwards served as President Director from 2015 to 2016. Her other experience includes serving as Commissioner of the Indonesian Clearing and Guarantee Corporation (2016–2023), Independent Commissioner of PT Bintraco Dharma Tbk (2016–2020), and Independent Commissioner of PT Mandiri Manajemen Investasi (2015–2019). The meeting was closed at 11:00 WIB.
