

**DECREE OF THE BOARD OF DIRECTORS OF
PT KUSTODIAN SENTRAL EFEK INDONESIA**

REGARDING

**THE AMENDMENT TO THE REGULATION OF
PT KUSTODIAN SENTRAL EFEK INDONESIA NUMBER I-C
REGARDING
SECURITIES SUB-ACCOUNT**

- Considering : a. Whereas in the framework of development and optimization of Securities Account utilization, among others, related to the process for the opening of Securities Sub-Account for the Exchange Transaction settlement over Equity Securities by the Account Holders constituting Clearing Members facilitated by PT Kliring Penjaminan Efek Indonesia (KPEI) to anticipate the growth of Securities Transaction, the increase of total number of Securities Issuer, as well as the increase of total number of investors in Indonesian Capital Market.
- b. Whereas to support the strategic program of KPEI as contained in letter a, will be required legal basis related to the opening and utilization of Securities Sub-Account for the Account Holder's Securities Transaction Settlement (hereinafter will be referred to as the "**Securities Sub-Account 084**") used by the Clients of the Clearing Member and/or the Account Holders as Clearing Members in order to accommodate the needs of KPEI aforesaid.
- c. Whereas based on the considerations as referred to above, then, KSEI considers it necessary to make adjustment to the provisions in the Regulation of KSEI Number I-C regarding Securities Sub-Account.

7. Letter of the Financial Services Authority Number S-116/PM.01/2026 dated May 19, 2026, regarding the Approval over the Amendment to the Regulation of KSEI Number I-B regarding the Main Securities Account and the Amendment to the Regulation of KSEI Number I-C regarding Securities Sub-Account.

HAS DECIDED

- To stipulate : 1. The Amendment to the Regulation of KSEI Number I-C regarding Securities Sub-Account as contained in the attachment to this Decree of the Board of Directors.

2. The Implementation of mechanism for the opening and utilization of Securities Sub-Account 084 shall only be applicable in the event that the Account Holder constitutes a Clearing Member who has fulfilled the entire requirements as stipulated by KPEI and KSEI.
3. With the enactment of the Regulation of KSEI Number I-C regarding Securities Sub-Account as referred to in Point 1, the Regulation of KSEI Number I-C regarding Securities Sub-Account (Attachment to the Decree of the Board of Directors Number KEP-0015/I/DIR/KSEI/0224 dated February 15, 2024, regarding the Regulation of PT Kustodian Sentral Efek Indonesia Number I-C regarding Securities Sub-Account) is revoked and declared of no longer applicable.
4. The implementing provisions regarding the mechanism and/or procedure for the opening and utilization of Securities Sub-Account 084 as well as matters which have not yet been sufficiently stipulated in the Regulation of KSEI Number I-C regarding Securities Sub-Account, will be further stipulated in the Circular Letter of KSEI (if any).
5. This Decree of the Board of Directors will be effectively applicable starting as of its date of stipulation, provided that any and all matters will be amended and corrected accordingly if there is any mistake in the stipulation and/or if it is considered necessary to make correction over this Decree of the Board of Directors.
